

Harlan Christian Youth Center COVID-19 Safety Plan

We are working diligently to make sure the Harlan Christian Youth Center remains a safe place for children and employees. We will continue monitoring the State of Indiana's health regulations and CDC guidelines to make sure we are at the forefront of sanitization and safety. The information listed below covers the basic sanitation procedures that will take place at the Harlan Christian Youth Center:

- Upon arrival from the school bus, children will be required to wash hands and/or use hand sanitizer. Hand sanitizer will be readily available in each room.
- Members will be reminded of proper sanitation habits. These would include proper handwashing and respiratory etiquette, avoiding touching their face, and limiting contact with others.
- Snacks will be packaged and seating will be spaced out to encourage social distancing while eating.
- PPE (Personal protective equipment), such as face masks, will be required when social distancing is not possible or as directed by state regulations and mandates.
- Rooms will be cleaned with EPA approved cleaners, such as 60% or greater alcohol, bleach cleaners, etc.
